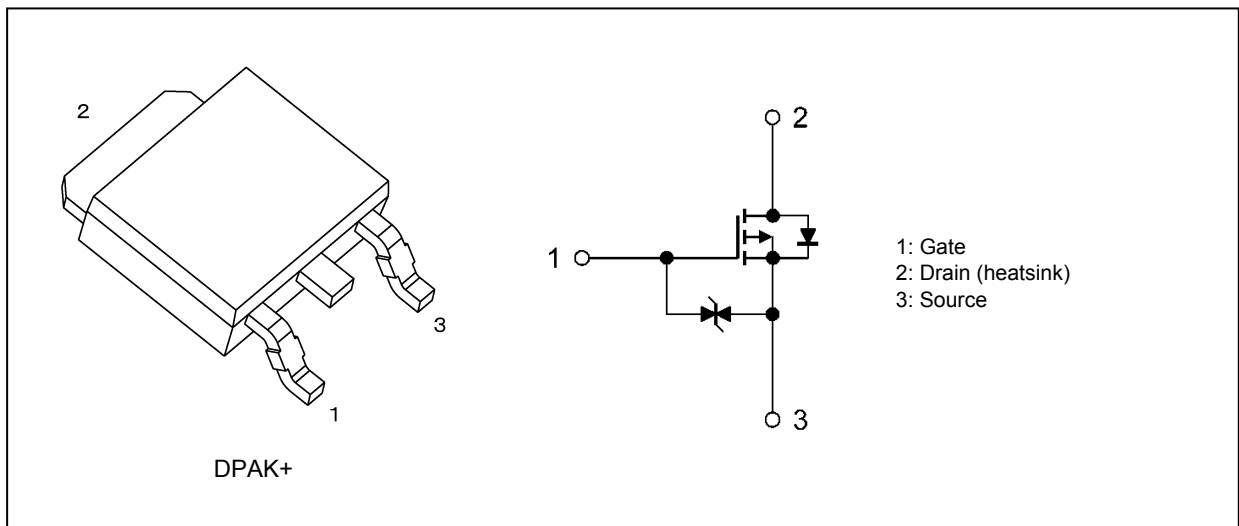

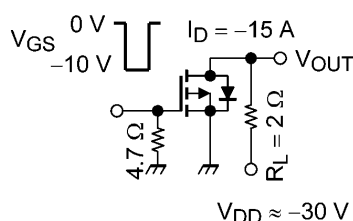

**Fig. 6.2.1 Switching Time Test Circuit**

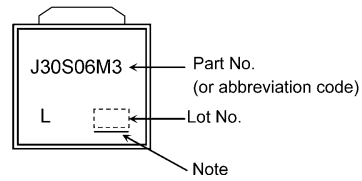

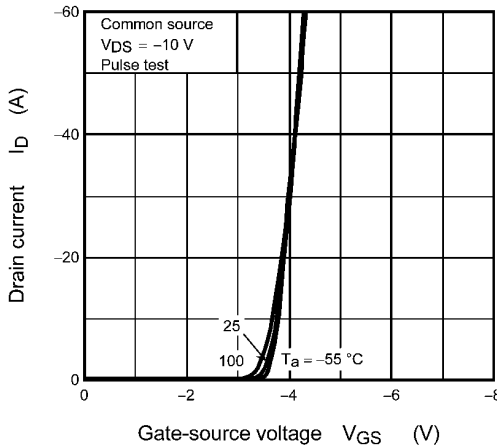

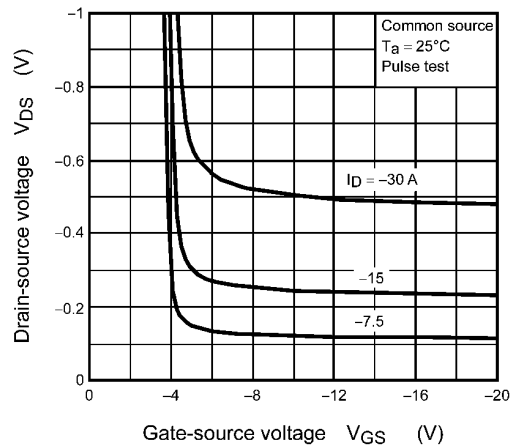
**Fig. 8.1 ID - VDS**



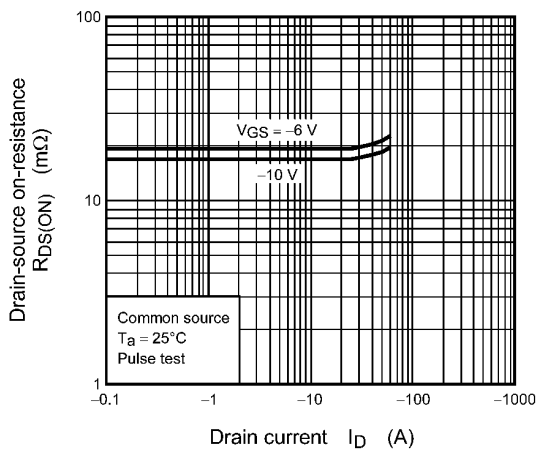
**Fig. 8.2 ID - VDS**



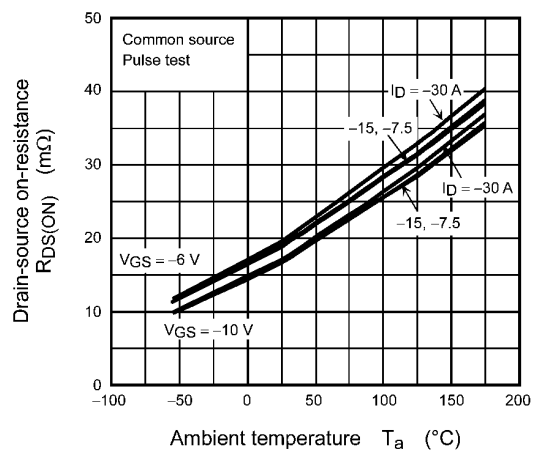
**Fig. 8.3 ID - VGS**



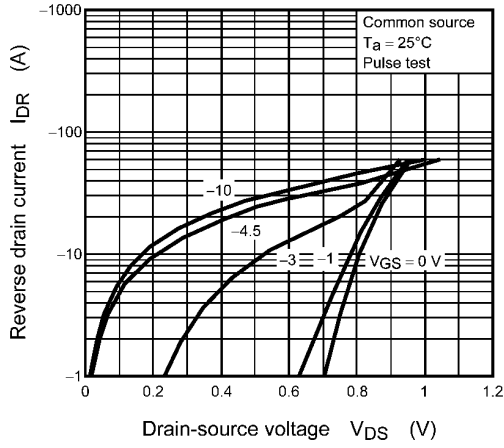
**Fig. 8.4 VDS - VGS**



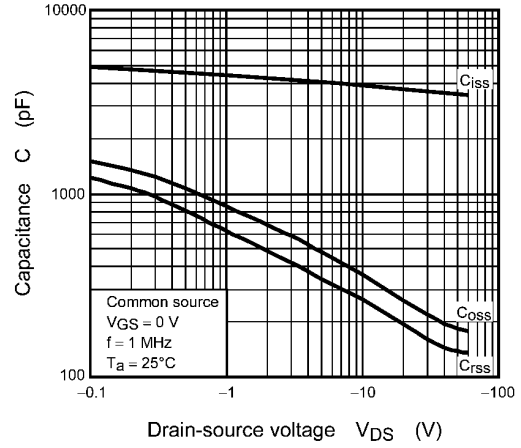
**Fig. 8.5 RDS(ON) - ID**



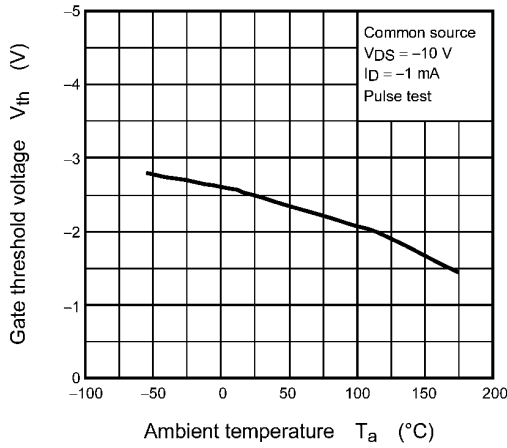
**Fig. 8.6 RDS(ON) - Ta**



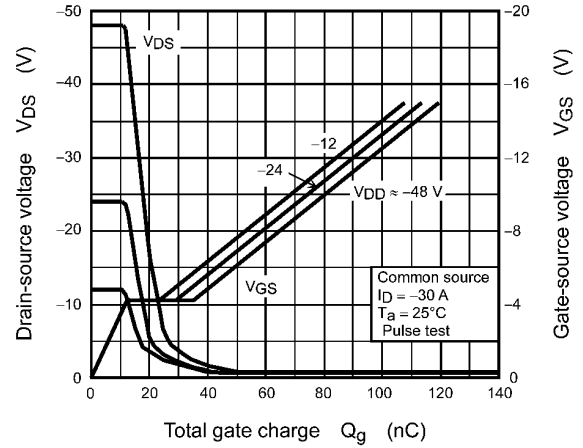
**Fig. 8.7  $I_{DR} - V_{DS}$**



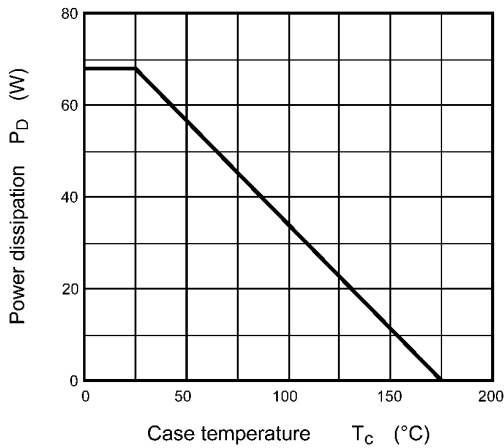
**Fig. 8.8 Capacitance -  $V_{DS}$**



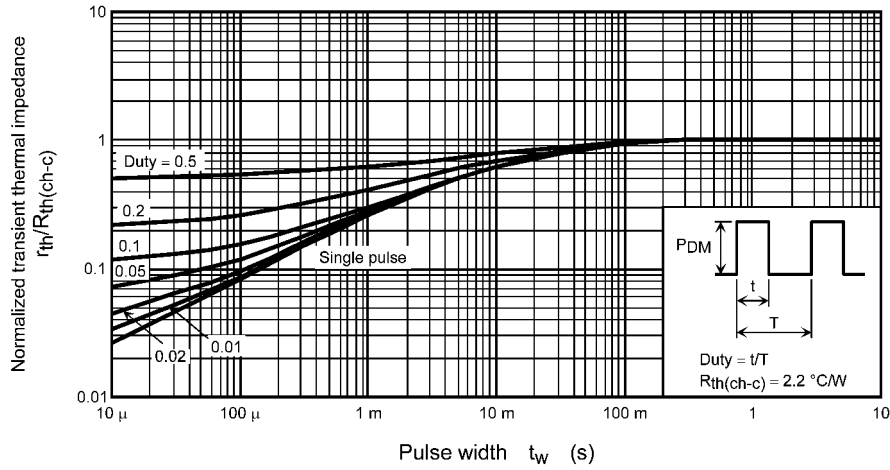
**Fig. 8.9  $V_{th} - T_a$**



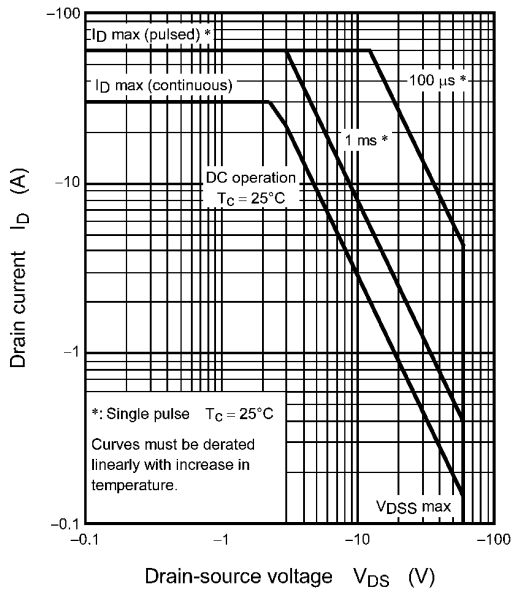
**Fig. 8.10 Dynamic Input/Output Characteristics**



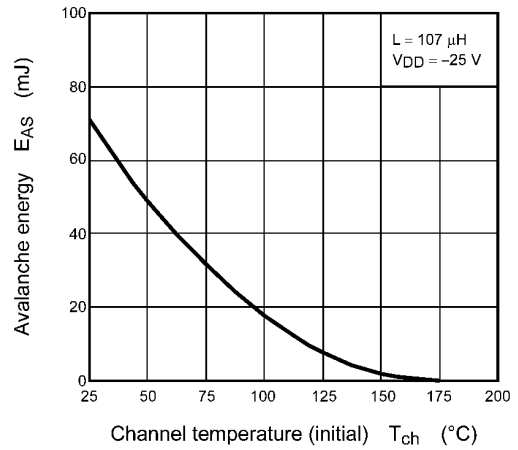
**Fig. 8.11  $P_D - T_c$   
(Guaranteed Maximum)**



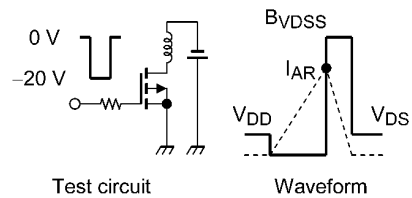
**Fig. 8.12  $r_{th}/R_{th}(ch-c) - t_w$**

(Guaranteed Maximum)



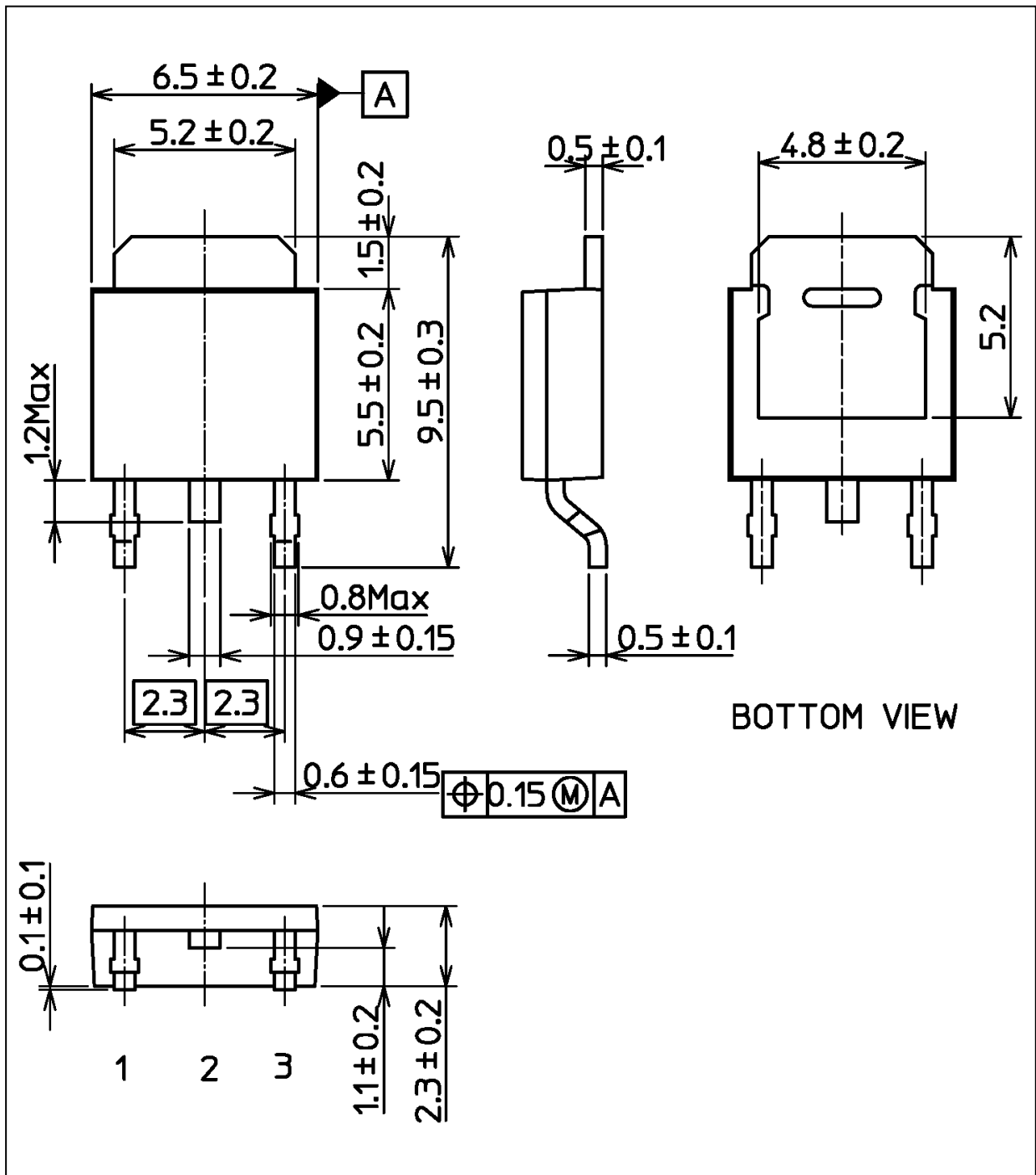
